On Monday 02/17/2025, I filed "Submission Number: 17398-253-852-064," and this TCR is a follow up to my Submission Number: 17398-253-852-064.

The "Material Misstatement" that I claim is the fact that the entity, and their CPA firm, both failed to list their massive cash embezzlement on their audited financial statements (their "audit report," see attached audit report).

Attached is the associated 48 PDF page audit report, for my Submission Number: 17398-253-852-064, and the single page "2018 FHSC Link" PDF file contains a link to get that 48 PDF page audit report on the official website for the Florida Auditor General.

For Securities and Exchange Commission (SEC) "Whistleblower" purposes, especially for the reward that comes with successful SEC "Whistleblower" cases, I claim domain over the fraud at NOT JUST Florida Health Sciences Center, Inc and Subsidiaries (which includes Tampa General Hospital), but I also claim domain (for the reward that comes with successful SEC "Whistleblower" cases) over EVERY SINGLE entity that commits this exact same fraud.

If every offending entity embezzles cash at the same percentage of gross (or net) revenue, then the ANNUAL embezzlement of cash, in just USA SEC reporting entities is likely in the double digit TRILLIONS of dollars (Gross National Product times the % of revenue value from above), so my SEC whistleblower reward should be at LEAST 1 TRILLION dollars.

This fraud is about embezzling LOTS of cash, and this fraud is accomplished in two steps: Step 1: Use "change values" on the audited Statements of Cash Flows (SCF) report.

Step 1 comment (A): For balance sheet line items OTHER THAN accrued liabilities, SCF report "change values" are ok, but for accrued liabilities, SCF "change values" results in shifting cash from "below the profit line" to "above the profit line," and when that happens, "Net Assets" is also affected.

Step 1 comment (B): To the untrained eye, this "dual" problem appears ONLY as an issue with cash, and since most people will easily be convinced that the dual "cash" problems cancel out, to zero dollars cash, they accept this situation as being perfectly acceptable. However, since Net Assets is ALSO affected, they miss the fact that a reduction in Net Assets facilitates the "Step 2" embezzlement of cash.

Step 2: Properly deduct accrued expenses from Total Expenses, and Net Assets, but then ALSO deduct accrued expenses from cash.

Step 2 comments: Since Net Assets was reduced in "Step 1," the offending entity simply walks off with the same amount of cash.

Bottom line: I want "my SEC Whistleblower" share of EVERY dollar recovered from EVERY entity that the SEC regulates, and I believe that (even at only 10%), my share of the recovered cash will be well over \$1,000,000,000,000 (one trillion dollars, or more USA dollars).

Below, dates are "12/31/1999," because I believe that this fraud existed since at LEAST the 20th century, if not MANY decades before that.
