Tampa General Hospital (**TGH**), and CPA firm KPMG, LLP, are always the **criminal** entities. Since **TGH** is a large subsidiary of Florida Health Sciences Center, Inc (**FHSC**), I use **TGH**. The **growing TGH-Embezzle crime** steals **trillions** in **cash**, annually, from **We The People**.

Before reading this book, please read the 16 pages in Books A through D. This is Book E: **Book E** - Post **TGH-Embezzle** (a) **Reparations** (b) **The IRS** (c) **The CPA Industry** (d) **Trials**.

If you haven't figured **it** out yet, or if I haven't **specifically** written **it** yet, then here's the key: **TGH-Embezzle** exists, because entities **don't correct cash** for the non-cash item **bad debt**.

On "accrual basis of accounting" reports, you **are** allowed to include non-cash items, but if...
...you do that, then you are **also required** to adjust cash for **all** non-cash line items, but if...
...you **intentionally** do **NOT** adjust cash for **bad debt**: You can just **EMBEZZLE** that **CASH**.

After ~2018, **criminal** entities (like **TGH**) pushed bad debt **up, & off the income statement**. Once this amazing step **HID** their crime from view, it was **almost impossible** for anyone,...
...except me, to figure out how Corporate America screws **We The People** out of our cash.

REPARATIONS - I proved that **TGH** under-stated **CASH revenue** by > 6% during FY-2023. GDP is Gross Domestic Product (USA). During 2025, the USA GDP might be \$92 trillion (T). So, **REAL** GDP might be ~\$98T with ~\$6T in **TGH-Embezzle** going to Corporate America.

Book R, Page 1: Depending on the average tax rate of all offending entities, and the count...
...of **innocent** USA citizens, **annual reparations** could be in the **range** of \$16,000 / person.

Many (if not most of the) minority owned businesses, likely, do NOT participate in this fraud...
...(who wants THEM to get rich, right?), so my estimate might have to go down a notch, but...
...many **HUGE** entities might embezzle cash at a **MUCH higher rate** than does **TGH**, so...?

In the "**Pot of Reparations Cash**" that we'll give to "**TGH-Embezzle** innocent" USA citizens: Include the "one time" bounty of cash that **We The People** will get from selling off **all** of the...
...assets that are currently owned by **all** of the people who are found **GUILTY** of this fraud.

Also: Since this is an **ANNUAL** thing, **TGH-Embezzle** reparations could be **PERMANENT**. We'll force the finance folks to continue stealing, but they'll give the cash to **We The People**.

When we give the boot to the rich criminals, **We The People** will continue to work our jobs. **We The People** will get **daily TGH-Embezzle cash wire transfers**, & live happily ever after.

The IRS - The Internal Revenue Service (IRS) should be "independent" of the CPA industry...

On the IRS corporate tax return Form 1120, **Bad debts** is a page 1 deduction. In **Book D**,...
...look again at **PAGE 3**. If bad debt is **TAX RETURN** revenue, **and** expense, you **SHALL**...
...ensure that bad debt was also on the **AUDIT REPORT** both as revenue, **and** as expense.

Why? Answer: If bad debt expense **IS** on the tax return, but it **IS NOT** on the audit report,...
...then (as I prove in **Book D, PAGE 3**) the entity **embezzled** bad debt, on the audit report...
...as an unreported reduction of revenue, and on the other side of that **UN-BALANCED**...
...accounting worksheet, the entity **embezzled** bad debt, on their tax return, as an expense.

Entities embezzle bad debt cash only once, but have to do it on two "competing" documents.

To boot, many (if not most, or all) **non-profit** (IRS Form 990) **TGH-Embezzle** participating...
...corrupt entities **hide** their bad debt expense on a line item (or more than one line item),...
...that is nothing more than a dumping ground for fraud. That (those) line item(s) contain...
...the word "Other," and may not require the entity to provide detail unless the line item is...
...greater than a certain percentage of another line item, which, **of course**, never happens.

The point is: Our own federal IRS tax system **intentionally** allows **TGH-Embezzle** to occur.

The IRS needs 3 revenue lines: 1 - Cash-in-hand, 2 - Accounts Receivable, and 3 - The...
...**Good Debt Revenue (GDR)** **that went bad** line **SHALL** match **Bad Debt Expense (BDE)**.

FYI: **GDR**, and **BDE** must **BOTH** be on (a) All audit reports, and (b) All tax returns. Period.
I don't care about the FRAUDULENTLY implemented FASB ASU 2014-09, or any other rule.
With **multiple** lines for **BDE**, and ALSO for **GDR**, analysts can make their own calculations.

So, **ALL** official forms **SHALL** have conspicuous lines for **GDR**, and **BDE**, and they **ALL**...
...**SHALL** match each other. What if the entity has a small **BDE** value, from clearing their...
...previous fiscal year (FY) accounts receivable, that unbalances **GDR = BDE**? Then what?

This is a great question, but the stupid criminals at **TGH** left a popcorn trail that I was able...
...to follow, so I know the answer to that question. The answer is: Just report that value on...
...a different line. So, the tax return "Deduction" area **SHALL** have not just ONE, but TWO...
...**BDE** line items: The 1st line item **SHALL** tie, to the penny (or, if rounded, dollar) to the...
...**GDR** value, and the 2nd line item will be for reporting **BDE** that was associated with the...
...previous FY accounts receivable bad debt value. Now, zero cash (\$0) can be embezzled.

How is this all of this fraud possible? That leads right in to the next topic - **The CPA industry**
The term "CPA" stands for Certified Public Accountant, or some legally equivalent variation.

We know how large entities (**TGH**) embezzle cash, but how do **small** entities embezzle cash?

Small business owner can (1) Take cash, (2) Write-off the invoice to bad debt, which allows...
...them to (3) Reduce reported revenue from other jobs by that amount. They **DOUBLE DIP!**

While the large entities (like **TGH**) have to depend on lots of people to write off accounts to...
...bad debt (like in a PFS [Patient Financial Services] type department), small entity owners...
...can falsify real invoices, keep the cash, and then **DOUBLE DIP** bad debt embezzled cash.

Small business owners can also (1) Create a false invoice (for, say, \$5,000), (2) Write that...
...invoice off to bad debt, (3) Write a \$5k check to themselves, (4) Cash the check, and...
...(5) Take a tax free vacation, because the tax CPA is in on it. **We The People** get \$0 in tax:
(1) Illegally offset a TAXABLE owners draw to revenue, and then (2) Embezzle the cash.
This is the same as taking a patient payment, and then just putting the cash in your pocket.
One person can get a few bucks that way, but **TGH** embezzles hundreds of millions that way.

RICO is the (USA Federal level) Racketeer Influenced, and Corrupt Organizations (Act):
States can have their own RICO statutes, but since **TGH-Embezzle** crosses state lines,...
...via (at least) CPA firm partnerships, it **obviously** violates Federal RICO laws (States can...
...prosecute people who violate their own State laws). So, when did **TGH-Embezzle** start?

TGH-Embezzle likely started before Congress had to "give those who ain't got a little more."
What're the lyrics? "Well, they passed a law in '64 to give those who ain't got a little more,...
...but it only goes so far, 'cause the law don't change another's mind when all it sees, at the...
...hiring time, is the line on the color bar." Do you understand what I'm saying here?

By the early 1960s, the **CPA industry** was **corrupt**, and it was in **every** industry, including...
...all levels of government. **TGH-Embezzle** was in full swing, not just at **TGH** in Tampa, FL.

Since "they" couldn't let people starve, "they" HAD to do something, so what did "they" do?

This is where things got even worse for "**We The People**." Sure, the federal government...
...started their now famous welfare programs, but instead of using **TGH-Embezzled** cash...
...to pay for those programs, "they" made **We The People** pay for those welfare programs...!

So, not only were "they" like a bunch of leeches on a **farm animal**, but then "they" made it...
...worse by attaching yet **MORE leeches** to that poor **farm animal**. **We The People** are...
...slowing bleeding to death, but don't worry about it, because we can always fix it by just...
...having KIDS, you know, so that our KIDS can fix everything..., but that's like plantation...
...slaves having KIDS in order to get more rations: We're all just creating **MORE SLAVES**.

State CPA Boards of Accounting: I'll push most of this sore spot into, say, some future book.
Suffice it to say: So far, our CPA State Boards of Accounting are a **HUGE** disappointment.
To quote that bitten "sticky" super-hero: "With great power comes great responsibility."

The **responsibility** for stopping **TGH-Embezzle** is with the people who issue CPA licenses.
Why? Each board is **responsible** for disciplining their own CPAs, not sitting on their thumbs.

The 2 main problems, for our CPA Boards, are (1) They are controlled by CPAs, who might...
...be committing **TGH-Embezzle** in their own private practices, and (2) Those Boards are...
...part of a State government, which means that their elected officials might be committing...
...**TGH-Embezzle** on the books of their own State government. If the people who **should**...
...help **We The People** stop this **crime** are, themselves, **involved in this crime**, then what?

Trials - I suggest having only one trial, and that trial will be **We The People** vs. **FHSC (TGH)**. We already have a great understanding of their books, so this will be a "slam dunk."

Important: Once you fully understand the **TGH-Embezzle** fraud, you'll know, for sure, that... it's **COMPLETELY ACCEPTABLE** to convict certain people of this fraud by analyzing the... audit reports, and the tax returns, that they voluntarily signed off on, and / or filed. This is... a mathematical GAME, and it allow them to embezzle cash from **We The People** (us).

We The People: Why do we pay these **CRIMINALS BIG** bucks to **embezzle OUR cash**?

The **TGH** auditor (KPMG, LLP) is an international CPA firm, so when they are found guilty,... we can convict all of their other clients with the same math. Since almost all of the large... CPA firms commit **TGH-Embezzle** like that **TGH** does, we can save **We The People** the... expense of having TONS of trials. Trust me, once the **TGH** criminals get convicted, all of... the other CPA firms, and all of their entities, will fold, and beg to, um, keep their heads.

Their "Universal Guilty Plea" (**UGP**, which is my new phrase) will include a **complete** list of... ALL of the frauds that they know of, and when I say COMPLETE, I do mean COMPLETE.

We The People demand:

- 1 From the guilty: A **complete** list of every fraudulent activity that they know of, or suspect.
- 2 True cash "reconciliations" for every audited entity. Start each report with a beginning... cash balance, and then show cash paid, and cash received, for every balance sheet... account. Change values are **never** allowed. We want to see TRUE FLOWS of CASH. (In Book R, see the middle two pages, which are page 2, and page 3. Kind of like that.)
- 3 Harsh justice for everyone who (1) Signed off on fraud, (2) Was a Vice President (VP),... or higher, and (3) Whose name is (was) listed on the website "Leadership" section. "With great power comes great responsibility." Do something **right now**, or **pay later**.
- 4 Similar to "Corporate Integrity Agreements" (CIA), every audited entity **SHALL** sign off,... one by one, on a LONG list of SPECIFIC statements about various possible frauds. Example: Like this, but more inclusive: "I certify that I (we) did **not** embezzle cash." (Etc.)

To my people, **We The People** (which does NOT include **TGH-Embezzlers**): I am trying to... save all of us from "them." They're "**Professional Embezzling Monetary Rapists**," and... their victims are **We The People** of Planet Earth. They cannot silence me, because I am... correct, and they know that they cannot defeat me in court. I'm asking for your assistance.

Assist me in stopping this fraud: If you don't assist me, RIGHT NOW, then you're dooming... your own descendants to the **monetary slavery** that **We The People** live under right now.

You're with me, or you're with "them." Make up your mind, and act accordingly. Thank you.
